MAGISTERIAL DECREE 01 / 2019

To all Dames and Knights, Brethren of
Our Sovereign Order of Saint John of Jerusalem
Knights of Malta
Federation of Autonomous Priories,
let it be known by the present letters that

We, Jose, by the Grace of God Hereditary Regent and Grand Chancellor of the Sovereign Order of Cyprus, Hereditary Prior Procurator General of the Grand Priory of the Most Holy Trinity of Villedieu and by the Will of Our fellow Knights Grand Master and Head of State of the Federation of Autonomous Priories of the Sovereign Order of Saint John of Jerusalem, also said of the Knights of Malta, in virtue of the Constitutional powers bestowed upon Us, and

considering that have been presented before Us several documents which constitute sufficient proof and evidence of wrongdoing, unconstitutional abuse of power, swindling, falsification of documents, fraud and corruption, perpetrated by our present Minister of Foreign Affairs,

in accordance with the Article I of Chapter IV and all the Articles of the Chapter VII of Our Constitutional Letter,

We come to decree and We do decree:

ARTICLE 1. By the present Decree We come to suspend immediately from office and from all his duties in Our Government the present Minister of Foreign Affairs

ARTICLE 2. By the present Decree We come to appoint Our Prime Minister to take in his hands, provisionally and until a new Minister is appointed, the Ministry of Foreign Affairs together and jointly with the office of Prime Minister.

ARTICLE 3. All the appointments, positions, titles and designations done, given or granted by the, until now, Minister of Foreign Affairs without the written ratification done by Charter or Decree by the Grand Master in His capacity as Head of the State and President of the Government in accordance with our Constitutional Letter, or done or requested by the Prime Minister in his capacity or under delegation of the Grand Master, are considered abusive, null and void, but without any prejudice for those who have accepted them in good-faith, this in respect for the principle of Bona Fide.

ARTICLE 4. All the Identity Documents, namely Diplomatic Passports which have not been issued by the Prime Minister's Office are from this moment on considered as NULL and VOID and must be returned to the Prime Minister's Office as soon as possible.

a) The use of the above mentioned documents after the date of the present Decree is considered as crime and fraud and the Office of the Prime Minister must inform the different Border authorities so the Holders will be considered as using a fake document.

ARTICLE 5. Due to the need of a total re-organization of Our Ministry of Foreign Affairs all the present appointments in the structure of this Ministry are cancelled, without any prejudice for the Knights and Dames who serve in this Ministry in several different positions, who will be appointed as soon as possible for the same or for new positions in that structure, in accordance with the needs of the re-organization to be done.

a) The members of MoFA who are deployed or assigned to the service of other Governmental bodies of the Federation must return to the MoFA and wait for new assignment.

b) The provisions of this Article do not apply to the Diplomats assigned and affected to Our Embassies in different countries.

ARTICLE 6. Sir Karoly Andras Nagy must return to the Office of the Prime Minister in the period of 48 hours after receiving the present Decree, all the Documents, Letters, Verbal Notes etc. issued and received by our MoFA, as well as all Seals and Stamps of all sorts and kinds, letter head papers, business cards and all other documents, and the website of the MoFA must be erased and removed from the Internet.

a) In case of noncompliance of this clause the Prime Minister is authorized to undertake all the necessary measures internal or external for its fulfillment.

ARTICLE 7. The Lieutenant General of Our Sovereign Order must at once present to Our Magisterial Court a report about of the misconduct of the Knight Sir Karoly András Nagy, for disciplinary procedures in accordance with Our Constitutional Letter. Until then Sir Karoly András Nagy is by the present Decree suspended of all activity as a Knight.

ARTICLE . The present Magisterial Decree is effective from this day on.

This decree, was given in two pages at Our Magisterial House, on this 18th day of the month of January of the year of our Lord 2019 and to it We affix Our Hand and Seals in use at this House.
